(The fee for EMDA members does not increase after Sept. 30)

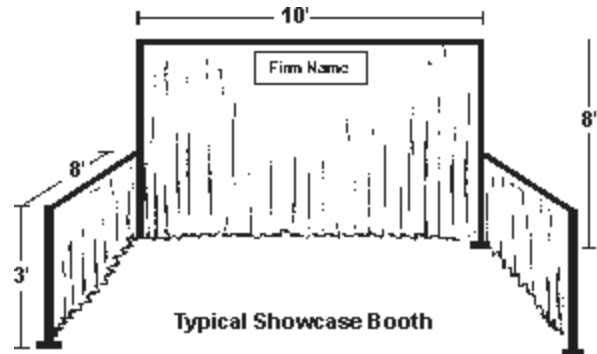
The Industry Showcase Exhibitor fee provides:

Registration as an exhibitor in the EMDA Industry Showcase is NOT registration for the EMDA Fall Convention, which is available to members only.

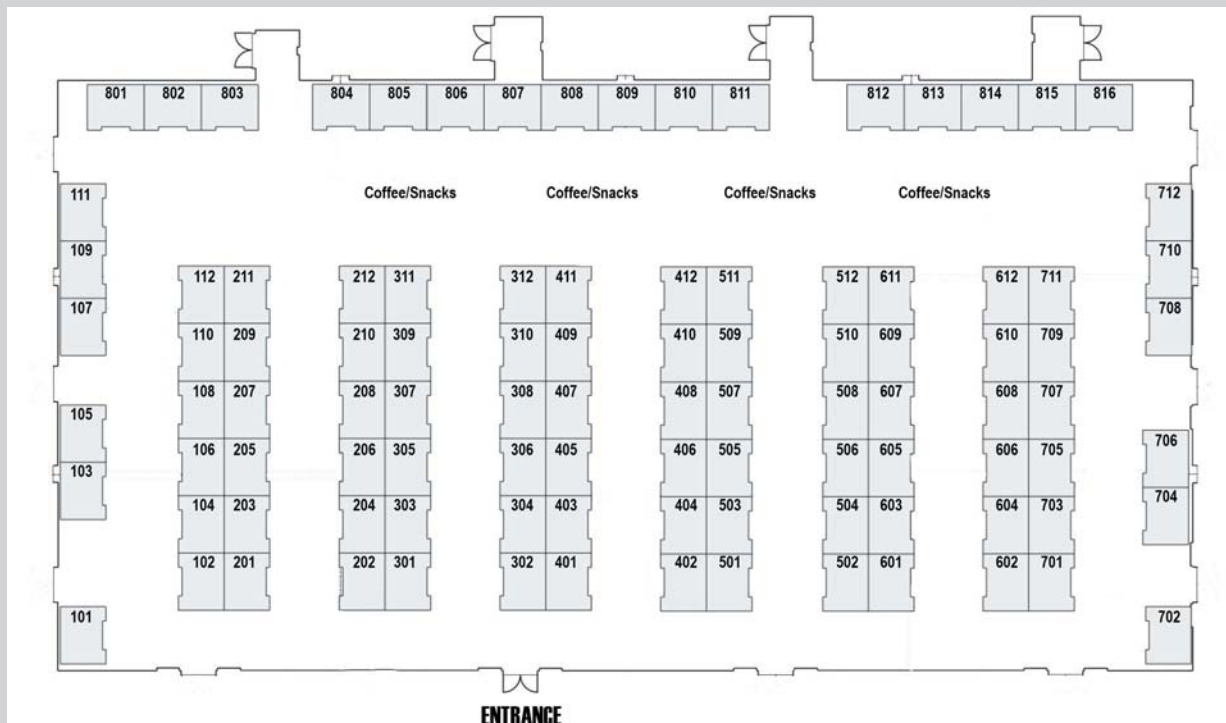
FEMA Convention registration does not include a booth space.

RULES & REGULATIONS

Submission of the EMDA Industry Showcase Exhibitor Registration Form and remittance of appropriate registration fees constitutes agreement to conform to these rules and regulations.

- Exhibitor service packets will contain details and pertinent information about mechanics of the **Industry Showcase** setup.
- Exhibitors will be admitted, *by Showcase badge only*, to set-up in the exhibit hall on:
Wednesday, November 3, 2021 – 3:00P – 7:00P
Thursday, November 4, 2021 – 7:00A – 12:30P
Booths must be clear by 7:00P on Thursday.
- EMDA will assign booth locations, however your preference will be given every consideration.
- Information listing Industry Showcase exhibitors and a brief description of their products and/or services will be published on the Association Web Site once an exhibitor's registration fees are received.
- Exhibitors may not assign or sublet any portion of booth space and no persons other than the exhibitors may exhibit or solicit business in the space.
- Sales of products or services not related to the shortline ag equipment industry will not be permitted.
- Obstructions of aisles will not be permitted. The exhibit area is for table-top display of advertising materials, small equipment and parts.
- EMDA is not responsible for injury to exhibits or exhibitors by any cause. EMDA assumes no responsibility or liability for any property of the exhibitor which may be located in the exhibit area or for drayage received and stored by Events 110.
- Exhibitor assumes responsibility and agrees to indemnify and defend EMDA and the Hotel and their respective employees and agents against any claims or expenses arising out of the use of the exhibition premises.
